

### **SELECTION OF PROJECTS**

#### **Development Finance**

Santiago Capital provided development finance for the construction of 4 fine new dwellings on Annamoe Road, Dublin 7.

Promoter experience and project feasibility are key in assessing development projects.



### **Bridging Finance**

Santiago Capital completed the acquisition of a mixed use portfolio in Abbeygate Street, Galway City. The portfolio comprises of retail, office, residential accommodation and 2 nightclubs.

As is critical for bridging transactions, the capital was made available and deployed quickly ensuring the project stayed on schedule.

### **Social Housing**

Santiago Capital has funded over 1,500 social homes at various stages of development. We funded schemes ultimately managed by Cluid, Respond, Oaklee & various councils.

The scheme depicted is a 40-unit housing estate in Clondalkin named Clover Hill Lodge.



### **Co - Funding**

In many instances Santiago Capital projects are attractive to third party funders. Where suitable Santiago Capital is content to accomodate cofunding from a range of investor types who are attracted by mid-to-high single digit fixed returns collateralised by marketable real estate assets.



### **OUR PROCESS**

#### **Initial Assessment**

A conversation with the promoter to establish the basics of what the capital is for and how it will be repaid.

## **V**Project Appraisal

Meet the promoter at the property to get a feel for the asset and the plans for it. Conduct initial due diligence on the project & promoter.

### Credit Committee

The project is presented to and considered by the credit committee. The rationale, merits and risks are assessed and challenged.

### Term Sheet

Terms are offered to the borrower (subject to due diligence) setting out our conditions, parameters and AML requirements.

### **OUR PROCESS**

### **Due Diligence**

We engage an independent valuer for a red book valuation & conduct further checks on the promoter and the assets. In case of a development project, feasibility study is required.

# Perfected Security

Legal Due Diligence is performed & drawdown checklist is completed. Perfected security is critical. We take security over assets we lend against & to the companies we lend to.

#### **Release Funds**

We release funds either in one bullet payment or in tranches at building milestones depending on the requirements of the borrower.

### **Project Monitoring**

We stay close to our projects and our clients. Projects are constantly monitored by a Portfolio Manager at Santiago Capital. For development projects, a Quantity Surveyor (QS) is appointed.
